Nutrition Education (SNAP-Ed) Estimated Allocations

TO: All SNAP State Agencies
All Regions

This memo shares the estimated FY 2023 allocations to assist States in preparing their State SNAP-Ed plans by the regulatory deadline of August 15, 2022. These FY 2023 allocations are for planning purposes only as the actual numbers will differ as additional data is collected. Based on current estimates, FNS projects the FY 2023 national SNAP-Ed allocation at \$486,000,000. The estimated allocation for each State is enclosed.

The final SNAP-Ed allocations will be released in late summer 2022 to reflect changes in SNAP participation and/or the actual June 2022 Consumer Price Index (CPI-U), per the statutory funding formula defined in Section 28(d)(1)(F) of the Food and Nutrition Act of 2008.
