SUBJECT: Supplemental Nutrition Assistance Program Education (SNAP-Ed)
FY 2016 Allocation

TO: Regional Office SNAP Directors

The FY 2016 final SNAP-Ed Allocations are attached. These updated allocations supersede the estimates that were provided for planning purposes on April 1 with the FY 2016 SNAP-Ed Guidance.

As you are aware, the final funding amounts continue to reflect the change in the funding formula to determine SNAP-Ed grant allocations, as described in the *SNAP: Nutrition Education and Obesity Prevention Grant Program Interim Rule* published on April 5, 2013. Beginning in FY 2014, funding was based on State shares of SNAP-Ed expenditures in addition to State shares of SNAP participation. The weighting of expenditures to participation was adjusted for FY 2016 and will be adjusted annually until it is 50/50 weighting of expenditures to participation by FY 2018.

For FY 2015, the requested appropriation for SNAP-Ed programming was \$407 million nationally. The difference between the FY 2016 final SNAP-Ed funding level of \$408 million and the estimated amount of \$411 million provided on April 1 is due to a fluctuation in the Consumer Price Index for All Urban Consumers. Final SNAP participation data may also account for some differences in individual State allocations. SNAP-Ed allocations are subject to the availability of Federal funds.

The Under Secretary's Office and SNAP looks forward to working with your team throughout the next year to continue to foster the development of comprehensive SNAP-Ed interventions and projects that include the implementation of evidence-based policy, systems, and environmental efforts in conjunction with well-planned and executed direct education. This includes our mutual goal to strengthen technical assistance for the States that are receiving funding increases.
